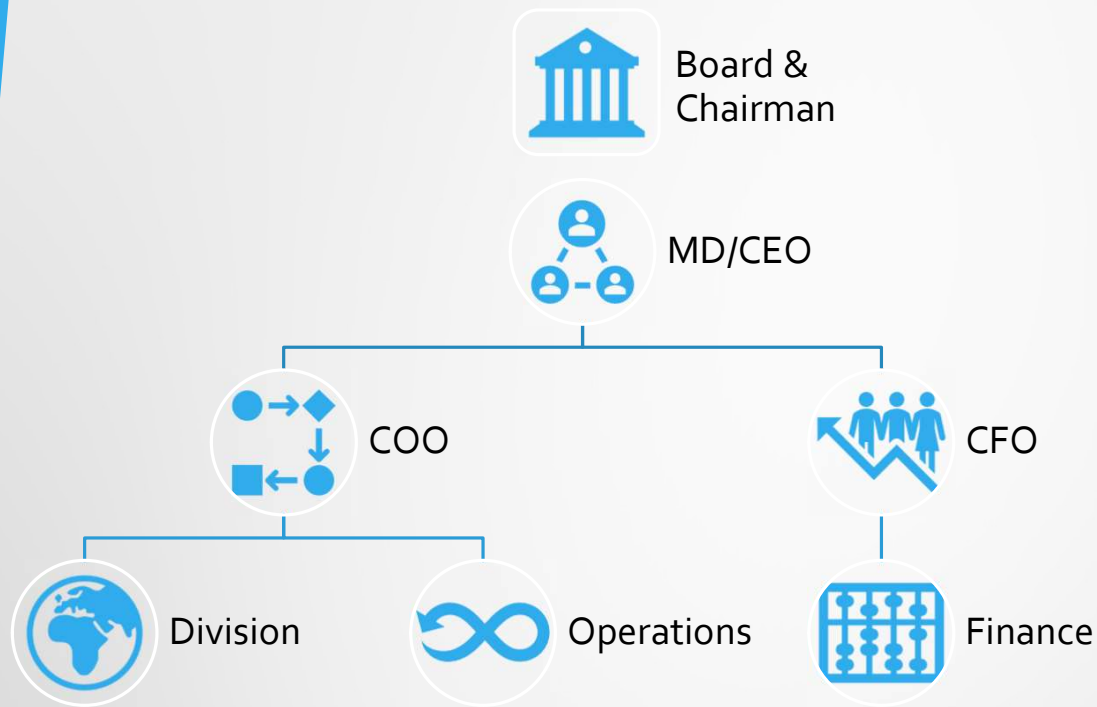


Our CSR

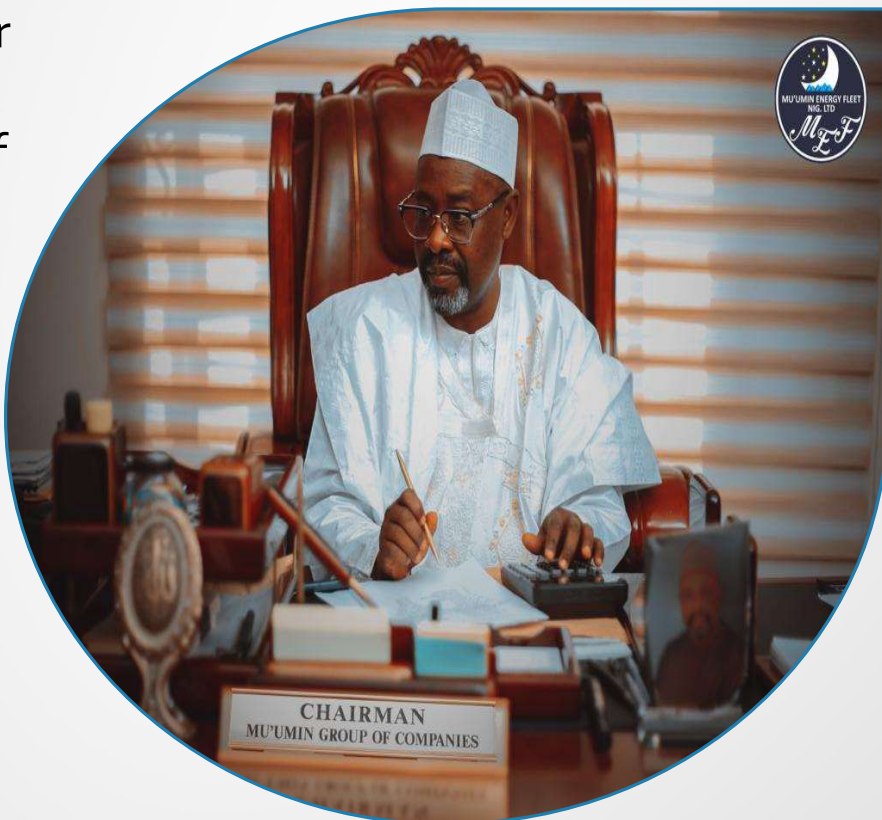

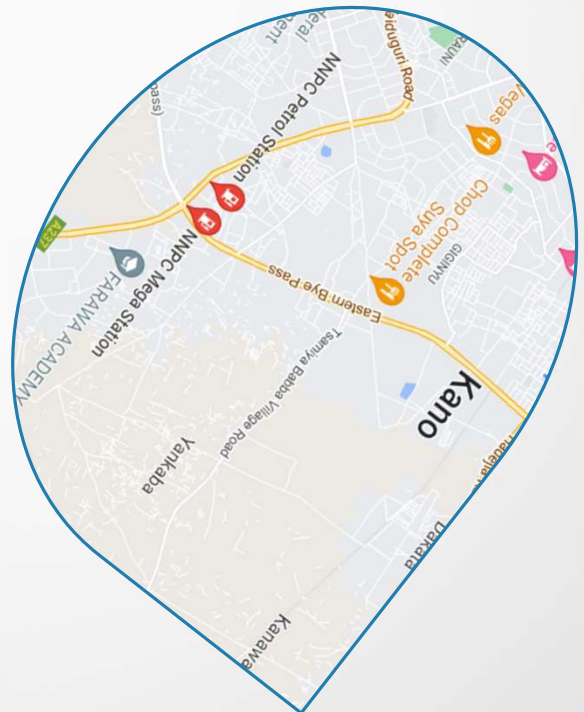
